Initial: \_\_\_\_\_ I agree to pay Solstice Training Center sales Commissions: 10% for horses under \$7,000 15% for horses over \$7500.

Initial: \_\_\_\_\_ I agree to pay half of the above commission to STC even if the horse sells through another agent or to a Buyer you yourself found while the horse is with STC, or within 2 weeks of departure from STC.

Initial: \_\_\_\_\_ I agree to pay Solstice Training Center the monthly cost of \$700/month due at the beginning of the month, plus any farrier/dentist/vet fees. I understand that if the horse sells before the month is over, remaining board fees will be pro-rated and added towards the commission due.

Initial: \_\_\_\_\_ I agree to leave the horse with Solstice Training Center for a minimum of 2 months if required. If I decide to pull my horse prior to the end of 2 months, I will be responsible for all advertising expenses as well as \$75 for photos and \$150 for each video of my horse prior to removing the horse from STC premises.

Initial: \_\_\_\_\_ I agree to pay for farrier and vet care as needed, farrier to STC, vet billed directly.

**Initial: \_\_\_\_\_ I agree that I am willing and serious about selling my horse and if an interested buyer begins the sale process (i.e. riding, vetting, purchasing flight for visit, etc), that I will not back out of the sale.**

If a horse is not suitable for the marketing program (i.e. can walk trot canter stop and turn in an outdoor arena with the average amateur rider) then they can enlist in full training (\$775/mo) with Solstice Training Center, if the horse is a problem horse or otherwise unsuitable for marketing/showing to buyers at the time of arrival, usually a minimum of 30 days.

**Solstice Training Center agrees to provide:**

- Full care stall board, stalls cleaned twice daily horse fed 3 times daily with top quality feed. Work 3 times a week by appropriate trainers or assistant trainers.
- Good quality photos and videos by STC done in a timely fashion (up to 2 weeks for first set based on weather training and availability) and updated as deemed necessary by STC. (professional photos upon request and at cost)
- Placement on the STC website ([www.solsticetc.com](http://www.solsticetc.com)), horse sales websites (dreamhorse.com, horseclicks.com, equinenow.com, etc), Facebook, and other appropriate venues as well as our extensive word of mouth network.
- Excellent care and conditioning to meet or exceed industry standards.

**Consigner/Seller agrees to provide:**

- Check one: \_\_\_\_\_ Original Registration papers signed but not dated OR \_\_\_\_\_ a copy of the front and back of registration papers and agrees to mail within 5 business days of sale to Buyer via certified or Express mail
- Halter and lead that can sell with the horse
- Current coggins or pay for veterinarian to provide one
- Vaccination, farrier, dental and worming history along with any information regarding previous health or soundness issues.
- Agree to pay for additional board at stall board rate (\$16.50/day) for up to 1 week after date of sale.

Consigner/Seller understands that if they choose to remove the horse from the marketing program that the horse can not be removed from the premises until all monies owed to STC for board/Farrier are paid.
