The undersigned person or parent(s)/guardian(s) agrees to assume all responsibility and risk from the use of riding horses while taking lessons or during general practice at Solstice Training Center. Further, the undersigned person or parent(s)/guardian(s) agrees to hold Solstice Training Center teachers, instructors, trainers, staff, and employees harmless from all damages of liability for any injury to person or property arising from riding lessons, general practice, equipment, and presence in the stables or grounds of Solstice Training Center or Diamond R Ranch/Toskhara Arabians. This release includes activities at remote locations (such as horse shows and trail rides.) The undersigned person or parent(s)/ guardian(s) acknowledge that horse-back riding and other associated activities are inherently dangerous. Although not likely, risk of injury is a possibility.

The undersigned person or parent(s)/guardian(s) consents to the performance of any necessary medical treatment in the case of injury. Such medical treatment includes, but is not limited to, x-rays, physical examination, anesthetic, medical or surgical diagnosis or treatment and/or hospital service. This medical consent applies to any activities at Solstice Training Center and Diamond R Ranch/Toskhara Arabians, hospital staff, and physicians to exercise their best judgment regarding the requirement of medical diagnosis or treatment. In the interest of obtaining the quickest possible medical treatment, the undersigned agrees to pay all fees for doctors, hospitals, ambulances, and any other reasonable and necessary medical charges that are incurred.

HELMETS ARE REQUIRED TO BE WORN AT ALL TIMES WHEN RIDING AT SOLSTICE TRAINING CENTER, DIAMOND R RANCH/TOSKHARA ARABIANS, OR REMOTE LOCATIONS UNDER THE INSTRUCTION OF SOLSTICE TRAINING CENTER REPRESENTATIVES. The undersigned acknowledges that any instance of riding without a helmet is at the choice of the rider or that rider's parent(s)/guardian(s) if the rider is or minor age. The undersigned specifically releases Solstice Training Center and its teachers, instructors, trainers, staff, and employees from any liability resulting from an injury or accident that might have been avoided through the use of a helmet.
